Applications are invited from the eligible candidates suitable for empanelment for Faculty at the position of Assistant Professor purely on contractual basis in the School of Undergraduate Studies (SUS), Dr. B. R. Ambedkar University Delhi in the following discipline. The panel will be valid for one year; however, validity of panel may be extended till completion of ongoing Semester, if required. At present there is requirement of 02 candidates (tentatively, which may increase and decrease as per requirement). The candidate will be engaged for teaching assignment from the panel only as per their merit in the panel after assessing the teaching load during the semester to meet the shortfall of teachers in Dr. B. R. Ambedkar University Delhi due to long leave of faculty members and due to requirement of additional teachers for newly launched Programmes etc.

Essential Qualifications and Experience

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/ relevant/ allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil./ Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET: Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/ Institutions subject to the fulfillment of the following conditions:- a) The Ph.D. degree of the candidate has been awarded in a regular mode; b) The Ph.D. thesis has been evaluated by at least two external examiners; c) An open Ph.D. viva voce of the candidate has been conducted; d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

The PhD degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).
- Note: The Academic score as specified in Appendix II (Table 3A) of UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 for Universities, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

C. Honorarium:

The candidates appointed on contract basis will be paid fixed emoluments not less than the monthly gross salary of regularly appointed Assistant Professor as per AUD/ GNCTD/ UGC norms.

If the services of any candidate are not found satisfactory, his/ her services may be terminated forthwith without assigning any reason to him/ her.

D. Other Instructions:

- 1. Benefit of reservation for various categories i.e. SC/ ST/ OBC candidates shall be given as per the policy of Govt. of NCT of Delhi.
- 2. Application forms have to be filled mandatorily in online mode only as available on the website of the University within the prescribed time limit as indicated in the advertisement.
- 3. The recruitment shall be made in accordance with the "UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018" as applicable.
- 4. In accordance with the UGC Regulations, 2018 as amended from time to time along with Dr. B. R. Ambedkar University Delhi Act, Statutes and Ordinances, including amendments made thereafter, applicants applying for the post of Assistant Professor must submit a certificate in the prescribed format as per **Annexure I & II** (as applicable) from the concerned University to the effect that their Ph.D. degree in the compliance with relevant UGC Regulations for award of Ph.D. degree.
- 5. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the interview. Where the number of applications received in response to this advertisement is large and it is not feasible or convenient to interview all the candidates, the University at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications / experience higher than the minimum prescribed for the post. The University, however, prefers candidate possessing higher qualifications and experience.
