C. Age: Not more than 63 years of age as on the closing date of the advertisement.

# D. Honorarium:

The candidates appointed on contract basis will be paid fixed emoluments not less than the monthly gross salary of regularly appointed Assistant Professor as per AUD/ GNCTD/ UGC norms.

#### E. Other Instructions:

- 1. Application forms have to be filled mandatorily in online mode only as available on the website of the University within the prescribed time limit as indicated in the advertisement.
- 2. The recruitment shall be made in accordance with the "UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018"
- 3. In accordance with the UGC Regulations, 2018, as amended from time to time along with AUD Acts, Statues and ordinances, including amendments made thereafter, applicants applying for the post of Assistant Professor must submit a certificate in the prescribed format as per **Annexure I & II** (as applicable) from the concerned University to the effect that their Ph.D. degree is in compliance with relevant UGC Regulations for award of Ph.D. degree.

- 4. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the interview. Where the number of applications received in response to an advertisement is large and it is not feasible or convenient to interview all the candidates, the University at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications / experience higher than the minimum prescribed for the post.
