## Event Report on 'Women and Girl Safety', by All India Women Conference

On 9<sup>th</sup> October 2024, School of Vocational Studies, Dr. B.R. Ambedkar University, Karampura Campus, in collaboration with the All India Women Conference (AIWC), organized a highly impactful awareness event on 'Women and Girl Safety'. This event was attended by the undergraduate and postgraduate students of School of Vocational Studies and it focused on addressing critical safety concerns for women and girls in both private and public spaces, encouraging the youth to become informed advocates for change.

The event was graced by a panel of distinguished guest speakers from AIWC, including Smt. Kalyani Raj, President of AIWC; Dr. Upasana Singh, Treasurer of AIWC; Smt. Kuljeet Kaur, Member Incharge of AIWC; and Ms. Ritu, Assistant Program Manager at AIWC. Dr. Priya Singh, Assistant Professor (Tourism & Hospitality), School of Vocational Studies, introduced the guest speakers and outlined the objective of the awareness event. She lauded the All India Women Conference for their continued dedication to promoting women's rights and safety, and for bringing this conversation to the university's students.

Following the introduction to the event, a warm welcome address was delivered by Prof. Sitanshu S. The students and speakers alike agreed that the responsibility for ensuring safety should not rest solely on women, but on society as a whole, and that men have a significant role to play in addressing the issue.



The event concluded with a strong call to action from the guest speakers, urging the students to be proactive in promoting safety for women and girls. The speakers expressed hope that the awareness campaign would inspire students to advocate for change in their own communities and beyond.
