Subject: Requesting HEIs to review and map relevant SWAYAM courses to be offered in the July 2025 Semester, with their existing University curriculum.

आदरणीय महोदय/महोदय,

The SWAYAM Board in its 26th Meeting held on 4th April 2025 under the Chairmanship of the Secretary (Higher Education), Ministry of Education, has approved 1696 Massive Open Online Courses (MOOCs) developed by National Coordinators such as UGC, CEC, NPTEL, IGNOU, IIMB, AICTE, NITTTR, and Institutions of national Importance to be offered in the July 2025 semester on the SWAYAM platform. The complete list of approved courses is available at www.swayam.gov.in and is also attached herewith.

As per the UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulations, 2021, all 1696 SWAYAM courses are eligible for credit transfer. Universities adopting these regulations may now allow their students to appear for SWAYAM course end-term examinations at their own institutions, following the UGC framework outlined in letter D.O.F.No.1-8/2017(SWAYAM) dated 27th August 2024.

The SWAYAM Course end-term examination provision, which was earlier limited to NTA or NPTEL centers, enhances access and convenience for students pursuing SWAYAM courses. It was also allowed to universities.

In order to maximise the benefit of these high-quality, interdisciplinary offerings for both students and faculty, you are requested to:

- Disseminate the list of 1696 courses to all Deans, Heads of Departments, and the SWAYAM Nodal Officer (SNO) and SWAYAM University Nodal Officer (UNO) in your institution.
- Convene a meeting of your University/Institutional SWAYAM Advisory Committee to:
 - i. Review and map relevant courses aligned with your existing curriculum and academic programmes.
 - ii. Determine credit transfer modalities and schedules for integration into the upcoming July 2025 semester.
 - iii. Publish the final approved list of SWAYAM MOOCs on your institution's official website by 10th July 2025, along with information on enrollment procedures and credit recognition for the benefit of students.

I hope the SWAYAM initiative may significantly enrich the academic ecosystem of your university and foster wider access to quality digital education for students.

Your participation in the meeting and proactive cooperation are solicited in this endeavor.
