At the outset, the Hon'ble Vice Chancellor welcomed the Deans, Directors, and IQAC members. The HVC initiated the meeting with a discussion on the AQAR data and sought updates on its status from all Schools, Divisions, and Centers. It was emphasized that all data should be submitted as soon as possible, and Deans, Directors, and Division heads must ensure that the required data is provided by the respective schools this week itself, noting that the deadline has already passed.

The following were discussed at the meeting:

1. Binary Accreditation

IQAC presented the **Binary Accreditation framework**, focusing on its implementation and the structured preparation of all **10 criteria** as per the new methodology. The session provided insights into aligning accreditation processes with the updated framework. Presentation and grade sheets template as and when available for state public universities will be shared with all Deans and Directors to facilitate the preparation of new procedures under the **Binary Accreditation** model. The IQAC will review the forthcoming document and initiate necessary steps to ensure compliance with the revised accreditation standards.

2. Regarding introduction of a new Criteria on Sustainability in binary NAAC framework (Rainwater Harvesting and Solar Panels)

The Estate and EMU Divisions were directed to take necessary and urgent actions regarding rainwater harvesting, water resource bodies, and solar panels including pit construction, water harvesting techniques, solar panels, and related initiatives at the university.

3. Assessment Related Policies

HVC directed that Academic Affairs should establish the office of **Controller of Examinations** in accordance with **UGC and NEP guidelines**. The Academic



Affairs need to formulate a re-evaluation policy, end-term exam policy, bridge course, and academic enrichment/remedial classes plan.

4. **Providing student support for academic success**

It was discussed that there should be a policy at the university level to address students' differential learning needs. The policy should include enrichment classes (remedial) for students, basis of identification learner's who need extra support in certain areas, identification of learners who are performing exceptionally well in different areas, and ways of supporting them. The HVC advised the Dean Academic Affairs to develop the policy regarding the same.

5. **Preparation of Competitive Examinations**

The Director of HRDC was advised to formulate a structured plan for conducting competitive exam preparation classes for students by internal/external faculty on a remuneration basis.
