Students who have already enrolled and are pursuing UG programme as per Choice Based Credit System (CBCS) are eligible to pursue 4-year undergraduate programme and the university concerned may provide bridge courses (including online courses) to enable them for transition to 4-year UG programme.

It is for information of all concerned that M.A. Clinical Psychology of two years duration will be implemented from the academic session 2025-26. The eligibility for admission to M.A. Clinical Psychology will be "*B.A. Psychology of four years duration with practical orientation/research in clinical psychology in the last year of graduation*". The institutions/ universities offering the 3 years UG program under Choice Based Credit System (CBCS) may offer bridge courses, as per public notice issued by UGC on 1-3-2024 (copy attached). The institutions offering 4-year UG program are not required to seek any permission from RCI as it would continue to be a UGC governed program. Nevertheless, to say that the approval of RCI is essential for offering M.A. Clinical Psychology course and the registration in Central Rehabilitation Register (CRR) would only be issued for those who successfully complete M.A. Clinical Psychology (4+2) years duration of RCI.

This issues with the approval of competent authority.
