PUBLIC NOTICE

Subject: Eligibility Status of Candidates for the post of Senior Assistant (General Secretarial Service & IT) in Dr. B.R. Ambedkar University Delhi in 7th CPC Pay Level –6.

This is with reference to Advertisement No. AUD/02/HR/2023 dated 18.08.2023 for recruitment to various Non-Teaching posts in Dr. B.R. 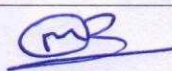
