- 1. - 2. Timings of the work will be 9.00 AM to 5.30 PM including lunch from Monday to Saturday.
- 3. Contractor is supposed to pay monthly electricity bill, as per the actual meter reading and submit the receipt to the Admin-KPC on each month basis
- 4. Contractor is supposed to deployed one person on the site for making photocopies for the students. Contractor will submit a Police verification certificate and Medical Fit Certificate against deployed p erson to the Admin-KPC within two weeks' time from the date of award for the tender after due form alities and L1 process laid by buyer on GeM portal.
- 5. Contractor is supposed to submit the following documents:
 - a. Non-Blacklisting Certificate of the Firm
 - b. Pan Copy of the Firm
 - c. Experience Certificate in the name of the Firm
- 6. Basically, tender is floated from the Karampura Campus, however, if services required, Contractor w ill provided the services at all campuses of Dr. B.R.Ambedkar University Delhi i.e. Kashmere Gate, L odhi Road and Qutub Institutional area.
