- 4. Class 10th certificate for Date of Birth proof
- 5. Class 10th and 12th Mark sheet and passing certificate
- 6. Migration Certificate
- 7. Reservation Category/ Caste Certificate (where applicable). Only OBC non creamy layer certificates issued by the Competent Authority of NCT of Delhi within the current year (2018) will be accepted.
- 8. Anti-ragging Affidavit. Two Affidavits on a Rs. 10/- non judicial stamp paper each - one by student and another by Guardian/Parents against ragging. (The formats are available on the website: http://aud.ac.in/admissions2018)
