Candidates can take admission on 07th and 08th August, 2018 from 10:00 am failing which their seats will be allocated to the next candidate. No queries will be entertained after the last date is over.

Candidate eligible for admission in more than one programme can only take admission in one programme.

The Students who are being provisional offered admission are requested to submit the following documents at the time of admission.

1. One passport size photograph
2. Copy of the online application form
3. Domicile certificate / Address proof
4. Class 10th certificate for Date of Birth proof
5. Class 10th and 12th Mark sheet and passing certificate
6. Migration Certificate
7. Aadhar Card
8. Reservation Category/ Caste Certificate (where applicable). Only OBC non creamy layer certificates issued by the Competent Authority of NCT of Delhi within the current year (2018) will be accepted.
9. Anti- ragging Affidavit. Two Affidavits on a Rs. 10/- non – judicial stamp paper each – one by student and another by Guardian/Parents against ragging. (The formats are available on the website: <http://aud.ac.in/admissions2018>)

Fees
