- I, Nitin Malik resident of Delhi in the capacity of the <u>Registrar</u> of <u>Dr. B. R. Ambedkar</u> <u>University Delhi, Lothian Road, Kashmere Gate, Delhi 110006</u> take oath and state asunder:-
- 1. That I am Registrar of Dr. B. R. Ambedkar University Delhi, Lothian Road, Kashmere Gate, Delhi 110006 and signing this Affidavit of behalf of it for which I am fully authorized.
- 2. That Dr. B. R. Ambedkar University Delhi has made an application to the NRC, NCTE for its constituent School of Study, namely, School of Education Studies, Dr. B. R. Ambedkar University Delhi, Lodhi Road, New Delhi 110003 for ITEPs, namely, BABEd (Foundational) and BABEd (Secondary) (name of the course) with an in take of 50 for each (total 100). The institution after fulfilling all the provisions of the NCTE Act, Rules & Regulations has got letter of intent under clause 7(13) of the NCTE Regulations, 2014 vide NRC, NCTE letterNo. NCTE/NRC/2324202205231124/DELHI/2022/LOI dated 17 November 2022.
- 3. That Dr. B. R. Ambedkar University Delhi, as a multi disciplinary university, has existing faculty members in different Schools of Study with relevant expertise that would be utilized for the BABEd programmes as per the University norms(details of faculty are at Annexure 1). These faculty membersare bonafide regular employees of the University appointed through due processes in respective Schools of Study. Essential core faculty will be appointed on an urgent basis for the BABEd programmes as per the NCTE norms and UGC and State government rules (copy of the faculty recruitment advertisement is at Annexure 2).
- 4. That the existing faculty members are and those that to be appointed will be the employees of the institution and will not be permitted to be employed in any other institution on regular basis. Any vacancy of positions will be filled as per due processes of the UGC/State government and the same will be intimated to the NRC-NCTE.
- 5. That the academic staff of the institution (including part-time staff) is paid salary in such scale of pay as prescribed by the UGC/University from time to time. The supporting staff shall be paid as per the UGC/State Government/Central Government pay scale structure.
- 6. That Dr. B. R. Ambedkar University Delhi has Technical support staff and Administrative Staff with the qualifications and experience as per norms and standards laid down by State Government/UGC/University. Core staff for the BABEd programmes will be recruited as per the norms. Salary is being paid to the staff members through bank/account payee cheque.
- 7. That <u>Dr. B. R. Ambedkar University Delhi</u> shall discharge all the statutory duties relating to pension, gratuity, provident fund, other benefits, etc. for its employees as per the admissibility.
- 8. The institution shall follow the norms of the NCTE as amended from time to time.
- 9. The details of staff appointed shall be displayed on the official web site of the institution i.e. www.aud.ac.in.
- 10. The information about staff has been verified from the original records submitted by the candidate at the time of joining employment.
