Circular

Sub: Clarification on Reservation Policy Admission/allotment of seats in Delhi Region / Outside Delhi etc. in Universities established by Govt. of NCT of Delhi.

1. In pursuance to Directorate of Higher Education, GNCTD letter no. DHE – 20(68)/AUD/Reservation Policy/2020-21/118 dated 10.06.2020, it is clarified that as per Govt. of Delhi policy, the reservation under Delhi Region (85%) are clearly defined as under:

“A candidate passing the qualified examination from a recognized school/college/institute located within the National Capital Territory (NCT) of Delhi to be considered for Delhi Region (85%).”

2. Accordingly, it is hereby informed to all applicants that those have applied or willing to apply for admissions 2024- 25 in various programmes under reserved categories /classes i.e SC/ST/OBC/EWS/Single Girl Child/Defence/KM at Dr.B.R.Ambedkar University Delhi, in their own interest, to apply for the certificates well in advance to the concerned Government Authorities for claiming the benefits of reservation.

3. Admission will be permissible to be qualified candidates in any programme in the following conditions:

- a) If qualified examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
- b) If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- c) If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.

4. For Delhi OBC category, certificate should be mandatorily issued from the Competent Authority of the Govt. of NCT of Delhi. Certificate issued by Govt. of India or any State Government will not be accepted under any circumstances. For claiming the reservation under OBC-NCL (Delhi), the non-creamy layer certificate should be issued after 31.3.2024.

5. For EWS category, the EWS certificate should be issued after 31.03.2024 stating valid for the year 2024-2025. Reservation for EWS category is applicable for unreserved category standard. Candidate claiming reservation for SC/ST category will not be considered for reservation under EWS category.

6. All the certificates should invariably be issued in the name of candidates.

7. For detailed reservation policy and formats of certificates, Admission Brochure 2024-25 may be referred at aud.delhi.gov.in.
