Note:

1. The list is provisional. It has been prepared in the order of merit on the basis of the CUET PG scores received from the National Testing Agency Paper Code considered by the University for the programme and eligibility criteria and availability of seats in each programme and the application form submitted online on the University website by the applicants.
2. The list of deficiencies listed above is not to be taken as exhaustive or final. This is a tentative list based on documents submitted by the applicant. If the applicant is found ineligible on further scrutiny or verification the University reserve the right to cancel their admission.
3. The provisional list for horizontal reserved seats (i.e. Defence, PwBD) and supernumerary seats will be announced separately.
4. In case, an applicant fails to produce the requisite documents within stipulated time limit of relevant merit list as detailed against their name, the seat will be offered to the next applicant in the merit list as per his/ her eligible category.
5. Applicants called in this shortlist, who fail to provide the requisite documents for online verification within the prescribed time limit as mentioned against their name will not be considered in the subsequent list. However, they may be considered for admission later, during SPOT round, if any, the dates for which will be notified later, on the University Website.
The admission during SPOT round shall be subject to the availability of seats in respective

category to which the applicant had initially registered/applied and further submission of mandatory updated documents as per eligibility criteria mentioned in Admission Brochure 2026-27.

6. The University shall require all provisionally admitted applicants to present their original documents physically at the University for verification. It is the responsibility of the applicant to keep themselves aware of the schedule for document verification and present their documents at the prescribed time.
7. It will be the responsibility of the applicant to rectify the discrepancy within the prescribed time limits. No claim for admissions, whatsoever, will lie on the University, if applicant fail to upload the requisite documents within prescribed time.
8. Applicants in their own interest who have uploaded reservation certificates for availing reservation benefits (SC/ST/OBC/Defence/EWS/SGC/KM/PwBD) at the time of registration at University portal are requested to check the Admission brochure 2026-27 uploaded on the website for ascertaining the category to be considered as per the reservation policy.
9. **An individual can take admission in only one programme at AUD at a given time. If you have already taken admission in a program at AUD please fill the transfer form available on the website and mail to pgverification@aud.ac.in with "TRANSFER" in the subject. You will receive an intimation regarding any differential in fee after paying which the transfer would be confirmed.**

Admissions under Reserved Category:

Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved
- If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.

The candidature of all applicants in the entire admission process is "PURELY PROVISIONAL" pending scrutiny of eligibility as mentioned in the Admission Brochure 2026-27 for the programme. In case, it is found at any stage of admission that the applicant does not fulfil the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Admission Brochure 2026-27 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admission.

It is extremely important that applicants pay the fee within the time frame allocated, failing which it will be concluded that the applicant is not interested in the programme applied and the admission offer will be automatically cancelled.
