- 3. Calling of the applicants for online document verification shall not be construed as entitlement for admission. 7. ### Admissions under Reserved Category:

Clarification for Admissions under Reserved Category: Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
- If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.
- 8. If two or more applicants have the same CUET PG Score, the marks in percentage of the qualifying degree (i.e. UG Degree) upto two decimal will be counted as the tie-breaker. if the UG marks in percentage is still tied, the older applicant will be given the admission.
- 9. Transfer case may be accepted from one programme to another programme. For such applicants (who want to take transfer), they must fill the transfer form available at Annexure-12 in the Admission Brochure 2023-24 and submit it to pgverification@aud.ac.in.
- 10. The candidature of all applicants in the entire admission process is "PURELY PROVISIONAL" pending scrutiny of eligibility as mentioned in the Admission Brochure 2023-24 for the programme.
