The course explores the ethics of design practice in social domains which would necessarily address issues of equity, justice, access and empowerment

6. Course Details:

a.Summary:

Having recognized the multidisciplinary nature of design and the potential of transforming human experience, this course will enable students to grapple with ethical dilemmas plaguing design practice and how ethics combined with individual values and larger concerns can be built into design practices themselves.

b. Objectives:

To analytically explore the multiple ethical issues facing design practice especially when it directly touches human well being

To analyse the academic inputs and experiences of the preceding semesters through the lens of ethics

To understand and articulate one's individual stand on the above issues with regard to one's own design practice

c. Overall structure:

The course would be conducted over one week of continuous engagement in workshop mode. It would be conducted by one or more invited experts. The structure would vary depending on the approach and suggestions of the invited experts.

d.Contents (brief note on each module; indicative reading list with core and supplementary readings)

Keeping within the outline described above, the course content would be shaped by the domain expertise of invited experts.

The final project is a detailed exploration of a social situation or a problem which will culminate into a proposed design solution/s to the issue/problem. The nature of the projects undertaken is located in larger social issues of equity, access, inclusion and empowerment. The focus and content of this course is thus, directly

connected with the larger vision of the University.

6. Course Details:

a.Summary:

Design Thesis is a comprehensive investigation of a particular issue or phenomenon articulated in the Independent Study and Design Thesis Research, manifested in a design project that engages the symbiotic relationships between the social and material inhabited world. Students will be actively encouraged to choose projects at an organizational scale and the design thesis culminates with the student being able to demonstrate how their project can achieve social change. The nature of projects while being located in real life, can either be either supported by a client/organization or the independent proposals for potential for implementation.

b. Objectives:

To demonstrate holistic application of learning of the previous semesters. To demonstrate how social design approaches, methods and tools can intervene meaningfully to enhance the quality of life for large majority of people and society. To visualize and manage all necessary stages of the design process- identification, analysis, ideation, prototyping, review and implementation.

To work in partnership with various stakeholders to ensure inclusive and participatory outcomes that is sustainable.

c. Overall structure:

The course is an amalgamation of Design thesis research, , project dissertation and seminar and final project thesis.

- **a.** Articulation of research methodology (Quantitative or Qualitative) in terms of audience/constituency/community being addressed.

- **c.** Identification of proposed design intervention with alternative approaches.

Final Seminar- Early December

Each student to present a presentation of the project to a group of school and AUD faculty as an open event.

Submission of Final Project: End December

The Final Project will be evaluated by internal and external guides and other experts. Copies will be sent to external jury member/s in advance and juries will be scheduled after giving 4-6 weeks for jury members to read the final document.

Evaluation Weightage

Presentations 1 and 2 will be the first and second evaluations of Final Project. (20% weightage each)

The third evaluation of the Final Project will be done based on the Seminar(20% weightage)

Final jury will carry 40% weightage.
