
#### **Opening remarks by the Vice Chancellor**

At the outset, the Hon'ble Vice Chancellor extended warm welcome to all the members to the 49th (Special) Meeting of the Board of Management for the 13th Annual Convocation. The Hon'ble Vice Chancellor informed the members about the 13th Convocation of the University scheduled on 13.12.2024 at 12 Noon. It was informed that the Hon'ble Lieutenant Governor of Delhi and Chancellor, Shri Vinai Kumar Saxena, shall preside over the convocation and deliver the Presidential Address. Convocation Address will be delivered by Chief Guest Hon'ble Justice Shri Dipak Misra, (Former) Chief Justice of India and Hon'ble Chief Minister of Delhi, Ms. Atishi, will be the Guest of Honour.

The Hon'ble Vice Chancellor further informed about the following initiatives that have been taken by the University since the last meeting of the Board of Management held on 07 October, 2024. Medinteasony

- i) It was informed that on the occasion of Constitution Day, 26.11.2024, the Outreach and Extension Division of the university organized a webinar titled Jano Apna Samvidhan, a handmade poster-making competition, and a pledge-reading ceremony. All members of the university participated in the Constitution Day celebrations in a hybrid mode, during which they read the Preamble of the Constitution of India and took an oath to uphold its values and principles.
- ii) It was informed that SHRM has organized a series of special lectures on Archaeology by senior ASI field Archaeologists. The lectures were on "Art of Indus-Saraswati", Heritage management: Challenges and Remedial Measures and visit to Rakhigarhi Harappan site. In addition, full day training on GIS remote sensing of field archaeology was conducted.
- lt was informed that the university hosted the second meeting of the Expert Committee on Indian Knowledge Systems on 19.11.2024. The committee includes eminent external experts from the Ministry of Education, the Indian Institute of Advanced Study, Shimla, the National Council for Promotion of Sindhi Language (NCPSL), the University of Delhi, NCERT, and Karnataka Samskrit University. All courses are revised. Tohere will be a total of 50 courses related to Indian Knowledge Systems (IKS) on offer across programmes. Additionally, two diploma programmes on IKS are also being developed by SHRM and Deshik.
- iv) It was informed that A Four-Week Training Programme on Higher Educational Administration for administrative staff of the university and other higher education institutions (HEIs) was launched on 19.11.2024. The programme will conclude on 16.12.2024.
- v) It was informed that the NSS organized the National Youth Parliament on 27.10.2024, fostering active and participative citizenship among the students of Dr. B. R. Ambedkar University Delhi. The event witnessed enthusiastic participation from all campuses.
- vi) It was informed that on Children's Day, 14.11.2024, the Fine Arts Society of the university organized an "Art Therapy Workshop" for Afghan refugee children.
- vii) It was informed that two second-year students of the BA Law and Politics programme, Jayesh Tripathi and Kanika Sharma, secured third place in the Constitutional Quiz organized by the Parliament on 16.11.2024.
- viii) It was informed that Dr. Benil Biswas has been commissioned as a Lieutenant in the National Cadet Corps (NCC), Ministry of Defence, Government of India, after completing 75 days of rigorous military training in the Pre-Commission (PRCN) Course SD-173 at the NCC Officers Training Academy (OTA), Nagpur, Maharashtra.

The Board of Management noted that a total of 1105 (tentative) students in the following Schools will be conferred with PhD, MPhil, MBA, MVoc, MA, BVoc, BA (Hons) Degrees/Diploma in various fields of studies during the 13<sup>th</sup> Annual Convocation of Dr.B.R.Ambedkar University Delhi scheduled to be held on Friday, December 13, 2024 at Dr.B.R.Ambedkar University Delhi, Kashmere Gate Campus, Lothian Road, Delhi.

It was submitted that the Academic Council in its 36th Meeting held on 22.10.2024 had ratified the revised Hindi version of Degree to reflect the intended meaning. Subsequently, a request was made to include the mother's name in the degree certificates, in compliance with the UGC Circular dated 6 June 2014 and the judgment of the Hon'ble Delhi High Court in W.P.(C) 8841/2023 and CM APPL. 33416/2023, Ritika Prasad vs. Guru Gobind Singh Indraprastha University.

In accordance with the same, the University had prepared the revised draft degree format including both the father's and mother's names of students which was presented to the Board of Management during the meeting for deliberations and consideration.
