The elections for Coordination Committee and Treasurer of the Students' Council of Ambedkar University Delhi Students' Union (Kashmere Gate) were scheduled on 25th of October 2018, from 11 am to 3 pm. Counting of votes was undertaken from 4:00 pm by members of Central Election Coordination Committee in the presence of candidates/representatives.
